Disclaimer

The organisers of all events take reasonable precautions to ensure the health and safety of all attending.

Anyone attending a Caernarfon Riding Club (CRC) event either as a rider, helper or spectator must take any and all responsible precautions to avoid and prevent any accidents occurring. Any instructions given either by a committee member or event organiser must be obeyed at all times.

- Hard hats to the correct safety standard **MUST** always be worn while mounted, the correct safety standard can be checked with any committee member or on the BRC website.
- Correct riding footwear must always be worn when riding and the footwear must have a heel.
- Body protectors **MUST** be worn for cross country to the correct safety standard and are highly recommended for show jumping as well, the correct safety standards can be checked with any committee member or on the BRC website.
- All children must be supervised by a responsible adult at all times, this includes whilst riding.
- All the riders equipment and tack must be in a sound condition and it falls on the rider to check their own equipment and tack before taking part in any event organised by CRC.
- All riders must agree to advise the instructor or event organiser of any illness or injury that could affect them in anyway before they mount a horse.

CRC and/or any event organisers cannot be held responsible for any theft, damage, loss, injury, illness or accident to any horse/pony or person's possessions or property.

Riding is a high-risk sport and the CRC recommend that you have your own rider's liability insurance and relevant public liability insurances.
